#### Abstract

This study is mainly focus on to find out the types of characters and characterizations of the main character in the film entitle "Titanic" by James Cameron. The study used two theories. The first theory is developed by Kenney (1998) that is used in analyzing the types of main character and the second theory from Wellek and Warren (1976) which is used in analyzing the characterization of the main character. The data were qualitatively analyzed and presented descriptively based on the theories adopted. Protagonist character was found as the finding result of the study. The type of character classified as major and dynamic character. In showing the type of the character and characterization of main character, the analysis used picture or scenes and the dialogue from the film. There are three aspects of characterization of all main characters that were found. Those are physiological, psychological and sociological aspects.

#### Abstract

Penelitian ini bertujuan untuk menemukan jenis karakter dan penokohan karakter utama. Penelitian ini menggunakan dua teori. There are two kinds of literatures, those are fiction and non-



fiction. One of the literary works that belongs to fiction is movie. According to Morner and Rausch (1998), characterization is a method by which an author creates the appearance and personality of imaginary persons and reveals their character. Characterization is the ability to bring the people imaginations to life for the reader, is judged one of the most important attributes of an author.

Many approaches to analyzing literary works, one of which is analyzing characters, studying how to analyze characters in films.

### 1.Physiological aspect

Physiological is something related to the characteristics of the body (physiology). Physiology is a sub-section of biology, which covers various topics such as organs, anatomy, cells, biological compounds, and their interactions as a whole. So, it can be said that physiology is the study of how the human body works, or the study of normal functions in living things.

### 2.Psychological aspect

Psychological is a field of science and applied science that studies human behavior, mental functions, and mental processes through scientific procedures.

### 3.Sociological aspect

The sociological aspect considers the cultural values that live in society. Philosophical and sociological aspects in its application really require extensive experience and knowledge as well as wisdom that is able to follow the neglected community values.

Characters are one of the important elements in a film, because they move the whole story and the types of characters involved in the film's story to create different types of conflict and tension and make the story more interesting. One of the films that is interesting to study is the film untitled Titanic. The main characters in this film are Jack and Rose. Titanic is a 1997 American epic, romance and disaster film screened and directed by James Cameron. This film tells the love story between Jack and Rose (Played by Leonardo DiCaprio and Kate Winslet) who came from different social statuses aboard the RMS Titanic which sank on its maiden voyage on April 15, 1912.

The first review is a thesis written by Suarini (2008) entitled "Analysis of Main Characters on *Jalan Hunger*" by Ben Okri. This study aims to determine the physiological, sociological and psychological aspects of the main character based on the theory of Egri (1960) and describe the motivations that shape the behavior of the main character based on Maslow's theory of motivation and personality (1970). The difference between this research and Yasa's thesis is that in Yasa's thesis, discusses the analysis of psychological aspects. While this study focuses on the analysis of the main character using the theory of Wellek and Warren (1949) and Kenney (1966). The similarity is the concern of both studies with the analysis of the main character.

The second review is a thesis written by Dewi (2019) entitled An Analysis of the Main Characters in the Movie The Fault In Our Stars by John Green. The data source for this research is the film *The Fault in Our Stars*, which was directed by Josh Boone. This study aims to determine the personality type of the main character based on Kenney's (1966) theory. And to describe the main character based on Morner and Rausch's (1998) characterization theory. The difference between this research and Dewi's thesis is the theory used in analyzing the characterizations. In Dewi's thesis, the analysis uses the theory proposed by Kenney (1966) and Morner and Rausch (1998). While this research focuses on characterization analysis using the theory of Wellek and Warren (1949) and Kenney (1966). What they both have in common is the study's attention to the main character analysis.

The third review is an article written by Pradnyani, Maharani & Candra (2022) entitled "Analysis of Directive Speech Acts: Film of Red Shoes and the Seven Dwarfs" (2019). The purpose of this study was to determine the types of directive speech acts used by the characters based on Kreidler's (1998) theory, which was taken from a book entitled Introducing English Semantics. The difference between this research and Pradnyani et al's article is that in Pradnyani et al's article, this study focuses on the analysis of directive speech acts. While this research focuses on characterization analysis using the theory of Wellek and Warren (1949) and Kenney (1966). What they have in common is that both studies analyze the characters in the film.

The fourth review is an article written by Sugiartini, Resen & Utami (2021) entitled Functions of Negative Imperative Sentences Found in Disney's Mulan (2020). The purpose of this study was to determine the function of negative imperative sentences used by the characters based on the theory of Quirk et al (1985), which was taken from a book entitled a Comprehensive English Grammar. The difference between this research and Sugiartini et al's article is that in Sugiartini et al's article, this study focuses on the function of negative imperative sentences. While this research focuses on characterization analysis using the theory of Wellek and Warren (1949) and Kenney (1966). What they have in common is that both studies analyze the characters in the film.

Based on the background above, this study focused on discussing who are main character in the film titanic and how is the main character's characterization in the film Titanic.

#### Method

This research used an observation method. The method applied is to watch the film in its entirety and then proceed by visiting the parts of the film that was selected. Recording parts of the film is also part of data collection related to the film dialogues that are related or relevant to the research. The analysis is presented descriptively with qualitative methods. The data was analyzed descriptively based on the theories adopted. In order to obtain the significant data that is required in this research, it is necessary to make efforts to provide a clear picture of the topics discussed. The steps in the analysis were watching whole film, understanding all of the main characters and characterizations, focusing on the main characters and characterizations.

### **Result and Discussion**

This section, the discusses the characterization of the main characters namely Jack and Rose in film Titanic. Based on the theory of aspect of characterization proposed by Wellek and Warren (1949), there are two aspect of characterization found in the film. They are Physiological aspect, and Sociological aspect.

### **1.** The main character in the Film Titanic
